REPORT OF THE TREASURER

At year-end 1990 the Southern Association for Institutional Research had an ending balance of \$28,017. Because of fewer paid memberships/registrations (a major source of revenue) in 1990 and due to a very active financial year, the balance decreased slightly from that of 1989. However, the Association continues to be quite fiscally sound.

Memberships during calendar year 1989 decreased from approximately 400 to 300 during calendar year 1990. As membership is closely tied to the attendance of the annual conference, the lower membership in 1990 was due to the decreased attendance at the conference in Fort Lauderdale. We believe that the attendance was down primarily because of travel restrictions in several southern states, particularly in Florida, the host state. [Although the number in attendance was down in Fort Lauderdale, the program and accommodations were excellent.]

In terms of the increased financial activity in 1990, the Association participated in both AIR and SAIR program grants, recognized several members with awards, contributed to the Institute of Desegregation, produced two proceedings (New Orleans and Durham conferences), paid more taxes than in previous years, and experienced higher conference costs in Fort Lauderdale.

Although the fund balance as of December 31, 1990 was lower than that of December 31, 1989, prospects for regaining the position of December 31, 1989 look very good. Yields from the 1990 CD investments will be greater than the bank interest of 1990, federal taxes for 1990 (\$0) will be considerably less, and attendance at the 1991 SAIR/SCUP/MIDAIR conference in Oklahoma City is projected to be much higher.

To illustrate the changes and growth in the Association, I have prepared two spreadsheets reflecting on six years of conferences and financial activity. These tables appear on Page 7 for your reference and information.

To reiterate, SAIR continues to be fiscally sound. Hopefully, we will be able to translate the financial success into more and better services to members in the future.

PRESIDENT'S MESSAGE

The 1990 AIR Forum theme "Institutional Research Coming of Age" addressed the issue of professionalism, with a controversial presentation by Frans A. van Vught who raised the question of whether institutional research can be described as a profession. Clearly van Vught challenged us to develop a scientific base if we want to elevate institutional research to a professional status. If we allow institutional research to be defined as a "management-oriented data collection activity"* that lacks a theoretical and scientific base, then van Vught predicts that institutional research will suffer a loss of esteem and credibility on our campuses.

I have thought about these remarks over the past few months, particularly in light of what SAIR can do to promote the professionalism of institutional research and planning. I personally believe that a strength of institutional research is the interdisciplinary approach to studying problems in post-secondary institutions. I also believe that, regardless of our varied disciplinary backgrounds and the diversity of our jobs, each of us working in the field of institutional research and planning needs a basic core of knowledge and skills to be effective. Defining this basic core of knowledge and skills is one of the challenges before our professional associations. The subsequent challenge is developing a systematic continuing education program which meets the needs of both newcomers and experienced institutional researchers and which addresses the needs of the technical support personnel, the analyst, and the manager.

I agree with van Vught that institutional research is at a critical juncture: if we fail to define the knowledge and skill base, institutional research

may very well become no more than a data production operation. I urge SAIR to become aggressive in elevating institutional research to a profession through establishing the competencies required of institutional researchers and planners and offering a well-thought out "curriculum" for training. The Professional Development committee has been charged with this very important task and seeks your input. I urge each of you to contact either Mary Sapp or me if you have ideas for the Professional Development Committee to consider.

Another attempt to elevate institutional research to a profession is to ask the Southern Association of Colleges and Schools (SACS) to recognize in its Criteria the need for adequate personnel with appropriate qualifications to staff institutional research and planning offices. I will ask the membership at the SIG meeting at the San Francisco AIR Forum, scheduled for 7:30 am on Monday, May 27, 1991, to consider endorsing the following revision of the 3.2 Criteria, with changes underlined:

> Institutions should assign administrative responsibility to an individual with the professional qualifications for carrying out institutional research and should provide sufficient staff with appropriate experience or training to support planning and evaluation processes.

If we are a profession, I believe that we as an association should be able to define, to our satisfaction, what we mean by "professional qualifications." I propose that we spend some time discussing this point at the SIG meeting in San Francisco and look forward to seeing you there!

1991 SAIR\MIDAIR\SCUP CONFERENCE OKLAHOMA CITY.....OCTOBER 6-8

This year's Program Committee, under the direction of Tom Bohannon, has put together a great program. The theme "MANAGING DIVERSITY - DELIVERING QUALITY: IN A CHALLENGING ECONOMIC ENVIRONMENT" is very timely as we all have been called upon to manage in changing demographics, coupled with less resources. The conference will be held at the Airport Hilton Inn West in Oklahoma City from October 6-8.

The 1991 Conference will be unique in many ways: One is that the MIDAIR group will participate with SAIR and SCUP, primarily because of the conference's location. Having the three groups present will be a first, and we are especially happy to have everyone's participation. Another change is that our program starts on Sunday. The Planning Committee felt that beginning the conference on the first day of the week, you would probably have a greater opportunity to obtain a reduced airfare through a Saturday night stay.

On Sunday, October 6, the conference will start with remarks from Dr. Lawrence A. Sherr. His opening remarks will provide the impetus for the "Delivering Quality" portion of this conference. Dr. Sherr presented several AIR Institute programs on "Principles of Total Quality Management." He has agreed to conduct a Professional Development Opportunity (PDO) pre-conference workshop on a similar topic.

Following the opening address, all participants are invited to attend a reception. We especially encourage newcomers to attend it since it will provide them an opportunity to get acquainted with and be welcomed by everyone.

Monday will be a very full day, and we plan to start with breakfast roundtables which will address a variety of relevant topics to planners and institutional researchers. You can gather goodies from the continental breakfast buffet and join a roundtable of one's choice. Note that these breakfast roundtables are included in the registration fee. For those who prefer a slower start-up pace, a continental breakfast buffet will be offered in separate quarters.

Monday's program will also include a morning general session, morning and afternoon concurrent sessions, and a box luncheon. During the box luncheon participants can join in regional SCUP group discussions to find out what is happening in SCUP and to meet their colleagues. The concurrent sessions will offer a wide variety of papers, panels, and software demonstrations from which attendees may select.

The Special Event at this conference is a private banquet on Monday evening at the National Cowboy Hall of Fame. The Hall represents seventeen western states and preserves accurately and authentically the rich heritage of the American West. Don't miss it!

Special Interest Groups will meet <u>Tuesday morning</u> during a continental breakfast. SAIR and MIDAIR will also hold business meetings that morning. These activities will be followed by more concurrent sessions and the conference will officially close with the Awards Luncheon (that afternoon).

This year's conference is packed with workshops, presentations, breakfast roundtables, and demonstrations that support the overall theme of the conference. Take advantage of this opportunity not only to participate but also to meet your colleagues. Seasoned members are encouraged to initiate contact with newcomers to assure that they feel the warmth and friendliness that has characterized our conferences.

Recreational activities throughout the conference will include a Putting Contest on Sunday, a morning jog on Monday, and a Tennis tournament on Monday as well.

More detailed information on the general and concurrent sessions will be announced in the next newsletter as well as in the forthcoming registration materials. Other activities and meetings throughout this conference will include additional software demonstrations, a Consultants' Corner session, a SUG meeting on Saturday afternoon (1-5 pm), and a MIDAIR (BIG 8) post conference.

Another feature of the 1991 SAIR/MIDAIR/SCUP Conference is the conference facilities. The Airport Hilton Inn West offers many nice features. It has 508 guest rooms, suites and townhouses, four swimming pools (1 indoor), a wading pool, a sauna, a whirlpool, a paddle tennis court, two lighted tennis courts, a putting green, an outdoor jogging track/fitness trail, a volleyball court, a gift and sundry shop, a barber shop, 20,000 square feet of convention area and meeting rooms, four clubs, two coffee shops, and superb dining in the true Hilton tradition. Room rates will be reasonable and within the per diem rates of the various states participating. Additionally, the facility is conveniently located close to the Oklahoma City airport and within walking distance of many great restaurants!

The Program Planning Committee, being sensitive to budget cutbacks and travel restrictions that are plaguing many of our institutions, will attempt to set the conference <u>registration fee</u> at the same rate as the 1990 conference. This fee will include SAIR membership dues, the Newcomer's reception, two continental breakfasts, a box lunch, and the Awards Luncheon. The Monday night banquet at the National Cowboy Hall of Fame will cost approximately \$30 per person and will include tours of the Hall, a delicious, all-you-can-eat barbecue dinner, and Country Western entertainment in the form of music and dancing. Our group will have sole use of the facility on Monday evening. Buses will be available to deliver and return members of the group as needed.

Features of the <u>National Cowboy Hall of Fame</u> include tours of: 1) the Western Performers Hall of Fame (which honors John Wayne, Walter Brennan, Slim Pickens, the entire Gunsmoke cast and other personalities who made significant contributions to the western film); 2) the Historic Western Art Exhibit (American West art of C.M. Russell and Frederic Remington; Taos artists Ufer, Sharp, Berninghaus, Blumenschein and Couse; and world renowned sculptures); and 3) the Contemporary Galleries (two galleries which showcase exhibits from the Hall's nationally-known contemporary western art collections.)

A <u>Call</u> <u>for Participation</u> for submission of proposals was sent to the memberships of the three organizations in mid-April with a mid-June deadline. All are encouraged to consider participating in the activities which we feel confident will provide an excellent conference.

FROM THE LOCKER ROOM

Many of you have heard that major reporting requirements are coming on institutional graduation rates, athletic graduation rates and campus security. Two important documents have recently arrived on campuses, and a third document provides a glimpse of the future. I encourage you to get copies, NOW!

- 1) The United States Department of Education sent out in early April its first "Dear Colleague Letter" (DCL) on the Student Right-to-Know and Campus Security Act. The DCL was mailed to CEOs, Registrars, and Financial Aid Administrators at each institution. If you are not one of the above and are just a hard working IR type, then I encourage you to get a copy from the chosen ones on your campus. The mailing also contained a copy of the Act, known as Public Law 101-542. The DOE will be publishing a Notice of Proposed Rulemaking and Final Regulations to implement the Act. Prior to that time a second DCL will be issued. This law applies to any institution that receives Federal financial assistance!
- 2) In late March, the <u>NCAA mailed its new graduation-rates</u> <u>disclosure form</u> to Division I institutions. This report is due by October 1, 1991. Division II schools will begin compliance in 1993. The Faculty Athletics Representatives, Directors of Athletics, and Senior Women Administrators of Athletics Programs were sent copies of these materials. The instructions are 37 pages and the forms are 50 pages.
- 3) On March 19, the <u>Knight Foundation's Commission On Intercollegiate Athletics</u> released its report, "Keeping Faith With The Student-Athlete: A New Model for Intercollegiate Athletics." The third component in its

"one-plus-three" model is "certification." This is a topic that is coming quickly and will involve the "accreditation" specialists on our campuses.
