The Accreditation Track welcomes proposals that address the revised principles of accreditation adopted by the Southern Association of Colleges and Schools. Our members will gain valuable insights into how your knowledge and expertise informs this important process of external peer review.

The **Assessment Track** addresses authentic approaches to evaluating administrative, support and learning outcomes. Whether reflecting upon insights gained from national surveys or highlighting improved learning outcomes based upon locally developed assessment measures, these sessions will highlight best practices.

The **Community College Track** is a growing area of interest at SAIR. The size and diversity of the community college sector requires us to learn as much as we can about these institutions.

The **Institutional Research Track** addresses the effective and efficient collection of data to inform college and university decisions. In addition to data collection, sessions may also address data analysis and dissemination to various stakeholders.

The **Planning Track** welcomes proposals that address how legitimate planning processes shape the agenda for your institution.

The **Technology Track** demonstrates creative and innovative uses of information technology to support institutional research and effectiveness activities.

The **Pre-Conference Workshop Track** provides the opportunity for in-depth discussion and instruction on a single topic. Demonstrations, exercises, group activities, and other methods of experiential learning are appropriate and desirable. Proposals should outline the specific objectives of the workshop, the intended audience (novice or experienced researchers, prerequisite knowledge/skills, etc.), the instructional techniques, and the qualifications of the instructor(s). Proposals also must include an estimate of the reimbursable expenses and the minimum and maximum number of participants allowed.

The **Roundtable** activity allows for discussion on a variety of topics of interest to conference participants. It is a unique opportunity to make new acquaintances and to take part in a free-wheeling discussion of a single topic over lunch. Networking at its best!

The **Special Interest Groups** activity allows conference participants to meet together as an affiliated group, a state association meeting, or a specific hardware/software users group.

Presentation Formats

Papers (45 minutes)

Papers should describe a research study or an effective process or technique (quantitative or qualitative), present a theoretical approach to a problem or issue, or review the literature on a topic of interest to institutional researchers.

Panels (45 minutes)

Panel presentations involve three or more individuals who present different perspectives on a common theme or topic. The proposal should describe the common theme/topic and the major points of discussion. The proposal should also describe how each panelist contributes a different perspective to the session.

Roundtables (60 minutes)

Roundtable sessions occur during lunch on Monday, September 27 and offer an opportunity for a convener to give a brief overview of a relevant topic that leads to an engaged and lively discussion. A proposal should include a description of the topic and the convener's relevant expertise and experience.

Software Demonstrations (45 minutes)

Presentations should demonstrate one or more software packages or programming solutions that are applicable to the work of institutional researchers. The proposal should describe the relative strengths, weaknesses, and special features of the product or solution. The presenter should also discuss the hardware required for the software/solution. If Internet access is needed, please request such access during the proposal process.

Workshare (45 minutes)

Workshare sessions provide an opportunity to share professional work products, effective practices, innovative applications, and creative solutions that are not ready to be presented as a paper. A proposal should include a description of the topic and its applicability to other institutions.

Workshops (3 or 6 hours)

Workshops provide the opportunity for in-depth discussion and instruction on a single topic. Demonstrations, exercises, group activities, and other methods of experiential learning are appropriate and desirable. Proposals should outline the specific objectives of the workshop, the intended audience (novice or experienced researchers, prerequisite knowledge/ skills, etc.), the instructional techniques, and the qualifications of the instructor(s). Proposals also must include an estimate of the reimbursable expenses and the minimum and maximum number of participants allowed. Workshops occur on Saturday and Sunday, September 25 & 26. Workshops which require a computer lab will be held off site at Delgado Community College. Transportation will be provided from the hotel to Delgado Community College and back. All other workshops will be held in the Executive Conference Center in the InterContinental New Orleans.

Proposal Submission Instructions Paper, Panel, Roundtable, Software Demonstration, Workshare, Workshop or SIG All proposals listed above should be submitted on-line at http://www.louisianau.com/sair proposal form Deadline: June 18, 2010 An abstract of no more than 100 words is required. Although some editing may occur, most abstracts of accepted presentations will appear verbatim in the conference program. A narrative representing the body of the proposal should cover the following: a) significance of timeliness of the topic; b) historical, theoretical, and/or conceptual framework; c) method of inquiry; d) analytical method; and e) intended audience. No reference to authors or their institutions should appear in the body of the proposal. SAIR will notify primary presenters in late July about the status of their proposals. Equipment: Each session room will have a computer projector and a screen. Please submit all requests and justifications for other equipment during the proposal process. SAIR will make every effort to accommodate reasonable requests. For additional information, please contact Program Chair, Ike Ikenberry (roy.ikenberry@belmont.edu). Facilitators: The session facilitators' tasks are to introduce the sessions, distribute session evaluation materials, return session evaluation materials to the presenter, and assure that sessions begin and end on time. Newcomers and veteran participants are invited to serve as a facilitator and become involved in SAIR. If you would like to serve as a facilitator, check the facilitator box when you register for the conference. Any questions you might have about being a facilitator should be directed to Sandi Bramblett (sandi@gatech.edu), Georgia Tech. Please note that all participants are expected to pay conference registration fees, and those submitting proposals acknowledge their intent to register by submitting a proposal. Honoraria are not paid to presenters, although reasonable expenses are reimbursed for pre-conference workshop materials. Join the SAIR 2010 Conference Group on Facebook! This group provides a forum to discuss the upcoming conference in New Orleans, and the many volunteer opportunities available to get involved in the annual conference and this outstanding organization. Pre-Conference Workshops By Cara Mía Braswell, Auburn University

SAIR members have begun to submit excellent proposals for pre-conference workshops. However we still have several slots available for Saturday and Sunday prior to the conference. Pre-conference workshops are designed to provide more in-depth training for either half-day or full-day time period. You may have attended a workshop recently which you would recommend to SAIR members or you may have developed a project that you wish to share with members. There is a wealth of knowledge within our own membership that we wish to identify. Additionally there are many new members looking for training opportunities. I know there are times during my day I find myself saying, "I wish I could improve my skills in" and that time becomes available rarely. The SAIR board would like these workshops to meet specific professional development needs that SAIR members have right now. Either I or SAIR pre-conference workshop committee members (below) would be glad to talk to you about your needs or ideas for workshops (or potential instructors). A discussion thread has been started on SAIR 2010 Facebook in an attempt to ask members for ideas of good trainers or topics. Workshop topic ideas were gathered last year and are on the 2010 Facebook page but our field is changing so rapidly there may be additional needs. So, while the time is now to submit your pre-conference proposal – you also still have time to discuss your ideas or knowledge of good trainers with peers. If you have your idea developed, be sure to submit early as we may also be able to help with refining or expanding your workshop.

Any workshops requiring labs will be held at Delgado Community College. The lab facilities at Delgado were updated in 2009 providing ergonomic-friendly labs with state-of-art technology, including smart-board technology with spacious classrooms. Anyone considering proposing a workshop requiring a lab can be excited about the technology available for instruction. The SAIR Board and members are very appreciative of Delgado Community College for opening their facilities to SAIR. Many thanks to Cathy Sarrazin from Delgado Community College along with V. Allen Gale from Xavier University for their time in-volved in setting up these lab facilities. You've both been great!



Call for Nominations for SAIR Awards

SAIR encourages nominations of its outstanding members for consideration for the following awards -

James Montgomery Outstanding Service Award

This award is given to an individual who has made a significant contribution to SAIR over an extended period of time. Nominees must have been a SAIR member for over five years and cannot be a member of, nor a candidate for, the Board of Directors during the year nominated. In addition, two of the following criteria must be met: (1) have been a member of the Board of Directors or a chair of a conference, or a presidentially appointed committee; (2) have been an officer of, or a recognized leader in, the establishment of a state or special interest group which has been associated with SAIR; (3) have made a professional contribution to SAIR by being actively involved in a combination of the following: (a) presented contributed papers at the SAIR conference; (b) organized, offered, or acted as a primary participant in workshops at the SAIR conference or workshops sponsored by an affiliated SAIR organization or group; (c) contributed in some other specific significant way that has advanced the professionalism of SAIR.

Distinguished Member Award

Distinguished Membership may be awarded to members or former members who have made distinguished contributions to institutional research. This award is a meaningful recognition of significant effort in the field of institutional research. The award is for the lifetime of the individual. (Persons retiring from active service in institutional research may be recognized through the award of emeritus membership rather than distinguished Membership).

A member or former member nominated for Distinguished Membership should meet the following qualifications: (1) has been an active and contributing member of SAIR; (2) has contributed substantially to the field of institutional research over an extended period of time, either in the practice of institutional research or in a supporting role (e.g. faculty, President); (3) has influenced higher education policies and practices through work or research.

Special Recognition Unsung Hero Award

This award recognizes the ongoing contributions of a member to SAIR and the field of institutional research and planning in the broadest sense. This Award honors individuals whose effort and initiative might not otherwise receive public recognition. The types of effort to be considered include management assignments, innovative projects or ideas, development of new initiatives, or other ongoing service to SAIR, other than as an elected officer. [For purposes of this award, "officer" is defined as President, Secretary, or Treasurer.] Officers are excluded in order to encourage initiative in fields other than political office and to ensure that the award does not become an appreciation award for past presidents.

All members of SAIR are eligible to receive the award with the following exceptions: (1) A person who has previously won the award. (2) Officers of SAIR shall not be eligible for five years after leaving their last officership.

In Memoríam—Dr. Cameron Fíncher

Dr. Cameron Lane Fincher, 83, passed away on March 13, 2010. In addition to serving at the University of Georgia for over 40 years, Dr. Fincher had a major impact on the field of Institutional Research. He was a charter member of AIR and received numerous awards from the Association. In 1998 Dr. Fincher was awarded the SAIR Distinguished Member Award at the Savannah conference. At that time he was noted as one of the "most prolific scholars in the south in higher education and institutional research".

Upon receiving the Distinguished Member Award, Dr. Fincher wrote the following message to the SAIR Board -

"I do indeed appreciate the honor of being designated a Distinguished Member of SAIR — and I hope that by thanking you as SAIR officials, I can convey some small measure of my appreciation to the entire membership. I was quite serious when I said that the recognition given me is really proof of the many friends I have. Both my wife and my children (n=4) have noticed the number and extent of the friendships I enjoy — and living with me for so many years, they have expressed amazement! Best wishes to each of you — and again, my personal thanks!"

THE GOODS ON GUMBO

This ultimate Creole dish is a tasty metaphor of New Orleans culture: not a melting pot, but a spicy mix of ingredients that complement each other without losing their individual flavors. Based on the African tradition of soup, gumbo is made with local seafood like our superb Gulf shrimp, crabs and crawfish, or a mix of meat and sausage (usually Cajun Andouille). Native American file' spice thickens and flavors the stock. Okra (from the Bantu nkombo) also helps with the thickening process as do Creole tomatoes. The 'holy trinity' of New Orleans food -- onions, garlic and green peppers -- is a must.

OUR LADY OF PROMPT SUCCOR

On January 7, 1815, the eve of the Battle of New Orleans, citizens spent the night in the old Ursuline Convent on Chartres Street in prayer ful vigil to Our Lady of Prompt Succor for victory. Fearing the arrival of British guns at their doors, they sought Our Lady's intercession, along with the Ursuline nuns in residence, for a miracle. In return, they promised to dedicate the City to her should the ragtag warriors drive the British forces away in defeat. The Americans won decisively. General Andrew Jackson personally visited the Convent to thank the faithful for their prayers, and grateful citizens donated family jewels to create fabulous gold crowns for a statue of Our Lady and the infant Jesus in her arms. Every year, on the anniversary of the battle, a solemn high mass is celebrated at the national shrine of the Ursulines in uptown New Orleans as the people follow through on their promise of thanksgiving. The chapel is open to the public where the Our Lady's statue can be venerated.

JAZZ!

They say that was born in the 1890's when Buddy Bolden put his cornet to his lips and blew a few hot notes to a cool tune. Just that simple and JAZZ was created, an American original and a world favorite. JAZZ mixes African and Creole rhythms with African American and European styles. The Irish, Germans and Italians contributed the presence of brass bands.

JEAN LAFITTE

He had the manners of a gentleman, the wealth of royalty, and the mystique of a legend. Some called him the Hero of New Orleans, to others he was known as "The Terror of the Gulf." He personally preferred the term PRIVATEER and he crowned himself as King of Barataria and the labyrinthine empire of waterways where he ruled nearly a thousand followers and where legend is that he buried much of his ill gotten loot. Today, the land of Lafitte is a haven for fishermen and home to quite a few of the descendants of the infamous pirate. It was of he that Lord Byron wrote: "He left a corsair's name to other times, linked one virtue with a thousand crimes."

MARIE LAVEAU

She passed away over a century ago and, yet, people still visit her tomb in the Old St. Louis Number One cemetery to gain a touch of the Voodoo queen's power. The tomb can be easily accessed in the old burial grounds on Basin Street, just outside the French Quarter. Those who believe mark the tomb with an X (many use lipstick) in hopes of securing fresh gris-gris, a voodoo spell or a charm that only Marie can offer.

STORYVILLE

It exists in name only. This was the area of the official red-light district of New Orleans, from 1897 to 1917, when it was decided far better to make war then love. Attempts at regulating and taxing the world's oldest profession failed until 1897 when a city alderman named Sidney Story drafted an ordinance confirming prostitution to a controlled district where it was still illegal, yet madams were required to have a license to operate their brothels. Instantly dubbed Storyville, the ladies cheerfully profited from consolidation, creating the 'Blue Book.' their own private yellow pages listing the houses, girls, services and prices for many of the 700 women who worked there. The book's famed photographs inspired potential customers to take a closer look. Business boomed, and Jazz greats like Jelly Roll Morton and King Oliver played in bordellos. The Louis Armstrong Park today sits across North Rampart Street, a Storyville area where many young musicians got a start. Look for Donna's Bar and Grill and the Funky Butt where you can still hear the music of the City.
